About our Clients

Who can come to Distribution Days?

We serve our clients without judgment so we do not require community members to receive our services. Our focus is on the NOCO communities and we do ask that those needing support to register to ensure we have the correct number of products.

Where/When do Distribution Days take place?

How often can clients attend the Distribution Days?

Clients can attend Distribution Days every month.

How do the clients select their products?

Grace Upon Grace Project honors the client's dignity by offering period products, diapers, and wipes and distributes products in an equitable manner. We ask that community members needing support to complete a registration form. This form allows us to ensure the needs of our community members are being met. Each community member can receive

Period Products: 30 total products (can be a combination of pads and tampons--different products).

Diapers: 100 diapers

Wipes: 150-200 wipes

What does a client's visit look like?

Distribution Days are when families or individuals will be able to pick up products. Our volunteers are very respectful and responsive to the clients and assist them in a caring and sensitive manner. Grace Up Grace Projects respects the client's privacy and works together to ensure a safe environment.

- Drive-thru style.
- Clients will stay in their car.
- We will place your products in the trunk/backseat for our clients.

Important Information

Due to the increasing need of individuals needing our services, there is a registration form that is required for our Distribution Day. Please note we are limiting registration to 150 clients for diapers/wipes and 100 clients for period products. They will be required to complete the form for each Distribution Day.

If a client registers and does not show up TWICE, unfortunately we will not be able to accept their pre-registration for future market days.

Where does Grace Upon Grace Project get the products given out to the clients?

The community is very generous with their help and support. Grace Upon Grace Project receives product and financial donations from generous people within our community.
